**GGA: FEDERAL BUDGET WIN FOR NY/NJ AIRPORT SAFETY**

*New provision prevents TSA from dumping \$8 million in security costs onto NYC area airports*

**(NEW YORK NEW JERSEY):** With the U.S. House of Representatives set to vote on the recently-proposed federal budget, the Global Gateway Alliance today praised a new provision to require the Transportation Safety Administration to continue staffing airport security exit lanes.

The agreement blocks the TSA from hitting airports and passengers two times – first, by raising security fees and then by turning around and abandoning the costs associated staffing of exit lanes. Without the provision, the TSA was set to unload \$8 million in new costs onto already financially-strained New York and New Jersey airports beginning January 1, 2014 – just weeks before a spike in security concerns associated with hosting the upcoming Super Bowl.

"When Republicans and Democrats in Washington can work together, it's good for our country. But when they can do the right thing by protecting passengers without placing additional burdens on our local airports, it's great for our airports and for more than 110 million passengers," said **GGA Chairman Joe Sitt**.

**GGA Executive Director Stephen Sigmund** added, "This is a common sense step and we're thrilled the TSA will step up to continue to protect the most vital airport system in the country."

Earlier this week, the GGA sent a letter to TSA Administrator John Pistole demanding TSA reverse its plan to eliminate federal agents at airport security lane exits. A copy of the letter can be found here:
